<u>INFORMATION</u>: Fixing America's Surface Transportation (FAST) Act allows for the allocation of Transportation Alternatives Program funds to be available for certain specified transportation activities; and, Federal funds usually require a twenty percent (20%) non-federal match. The 2013 Strategic Transportation Investments Law (STI) requires Local Government Agencies to pay the non-federal match for stand-alone

bicycle and pedestrian projects. Nish Trivedi will present a resolution in support of eliminating or reducing the local match requirement.
