<u>INFORMATION/ACTION</u>: Cy Stober, Development Director and Brian Byfield, Senior Transportation Planner with Ramey Kemp & Associates will present Mebane's newly adopted 2040 Comprehensive Transportation Plan. The comprehensive long-range transportation planning document will serve as a guide to ensure the safety, convenience, and multimodal access for Mebane residents and visitors. Mebane is requesting the TAC adopt the CTP for formal use in regional prioritization efforts and the 2045 CTP and MTP updates.

4) Triangle Region Air Quality Conformity

<u>INFORMATION</u>: The Triangle Region is required to demonstrate air quality conformity for the Triangle's Metropolitan Transportation Plans and TIPs. As a portion of the BGMPO planning area includes Orange County, the TAC is requested to approve the MTP/TIP conformity determination resolution and authorize the Chair to sign the resolution between 11/14/18 and 11/21/18 as the October TAC meeting will occur before the public/agency review comment period ends. The BGMPO is one of four organizations that will need to make determinations: 1) Durham-Chapel Hill-Carrboro MPO; 2) NC Capital Area MPO; 3) Burlington-Graham MPO (for the portion of Orange County in BGMPO jurisdiction); and, 4) NCDOT (for areas of the air quality region outside of MPO boundaries).

5) Transit Asset Management Plan

<u>INFORMATION</u>: The MAP-21 final rule established a strategic approach that ties transportation performance measures to financial investment and policy decisions. States and MPOs are required to integrate goals, objectives, performance measures, and targets into their planning processes, TIPs, MTPs and long-range statewide transportation plans. The final rule also requires that for transit-related targets, States and MPOs must coordinate their performance measures in all MTPs and TIPs updated after October 1, 2018. Transit agencies that receive federal funding and own, operate, or manage capital assets are required to create a TAM plan through an individual or group plan. The TAC is requested to adopt resolutions supporting the ACTA, Link Transit and Orange Public Transportation Transit Asset Management (TAM) plans as participants in NCDOT Group TAM Plan. The TAC is requested to provide conditional approval to the Piedmont Authority for Regional Transportation (PART) and Go Triangle TAM plans as non-group plan participants pending their Boards' approval.

RECOMMENDATION: 1) Review and discuss; 2) Recommend TAC approve agencies TAM plan resolution; 3) Conditional approval by the TAC of the Piedmont Authority for Regional Transportation and Go Triangle TAM plans.
