5) Local Match Requirement Resolution for Bicycle and Pedestrian Projects

INFORMATION: The 2013 NC Strategic Transportation Investments Law (STI) requires Local Government Agencies to pay the non-federal match for stand-alone bicycle and pedestrian projects. Many jurisdictions within the state do not submit bicycle and pedestrian projects for prioritization due to the inability to secure the required 20% local match.

INFORMATION: The BGMPO window for accepting P6.0 projects is April 1 – May 31, 2019. The TCC P6.0 Subcommittee developed criteria for BGMPO candidate project submissions that align with the existing NCDOT project scoring criteria. submission by BGMPO member jurisdictions. The Subcommittee also recommends a submission cap of 10 projects per mode.
