INFORMATION: The BGMPO Transportation Improvement Program (TIP) and 2050 Metropolitan Transportation Plan (MTP) consists of projects that are included in the NCDOT 2026-2035 State Transportation Improvement Program (STIP). INFORMATION: As the subrecipient of Federal Transit Administration Section 5307 formula funds for the Burlington-Graham Urbanized Area, the MPO has the responsibility to develop the methodology to suballocate federal funds among the five regional transit operators in accordance with the MPO Transit Allocation Plan and “Split Letter” schedule. Transit agencies must provide their respective non-federal matches.

5) Allocation of Local Input Points for BGMPO P8.0 Regional Impacts Projects

(pg. 25-27) (25 minutes)

INFORMATION: The TCC and TAC approved the BGMPO P8.0 Local Input Point (LIP) methodology for assigning LIPs during their respective March 2026 meetings. In accordance with the BGMPO methodology, up to 100 points may be awarded per project. The MPO has 1,400 points available to assign to Regional Impact projects. The projects that are assigned points will represent the BGMPO's transportation priorities for funding in NCDOT's 2028 – 2037 State Transportation Improvement Program. The deadline for allocating LIPs for Regional Impact is August 28, 2026. The BGMPO P8.0 list of quantitative scores for transportation projects by mode was released on May 29, 2026. Additionally, a public engagement event was held on June 19, and a website was launched to gather public input on priorities.

RECOMMENDATION/ACTION: 1) Review the BGMPO P8.0 quantitative scores project lists and discuss; 2) Develop the draft P8.0 Regional Impact Project list for the assignment of Local Input Points; 3) Allocate Local Input Points (up to 100 points each) to the Draft P8.0 Regional Impact List.

Resolution of Support for Village of Alamance Accelerated Plan

Eliud mentioned that the Village of Alamance is applying for the NCDOT Multimodal Planning Grant Initiative, an accelerated plan option appropriate for communities with fewer than 10,000 residents. This planning effort will identify key areas for walking and bicycling improvements and produce project cut sheets to support future funding requests. The plan and its deliverables will help the Village pursue projects that improve safety and access for people who travel without vehicles. Eliud also mentioned that Analysis shows the NC 62 segment through the Village of Alamance is among the top 10 percent in terms of risk of fatal and serious injury in North Carolina. NCDOT requires a resolution in support of the application. Ricky Hall made a motion to adopt the resolution, and Steve Carter seconded the motion. The motion was unanimously approved.

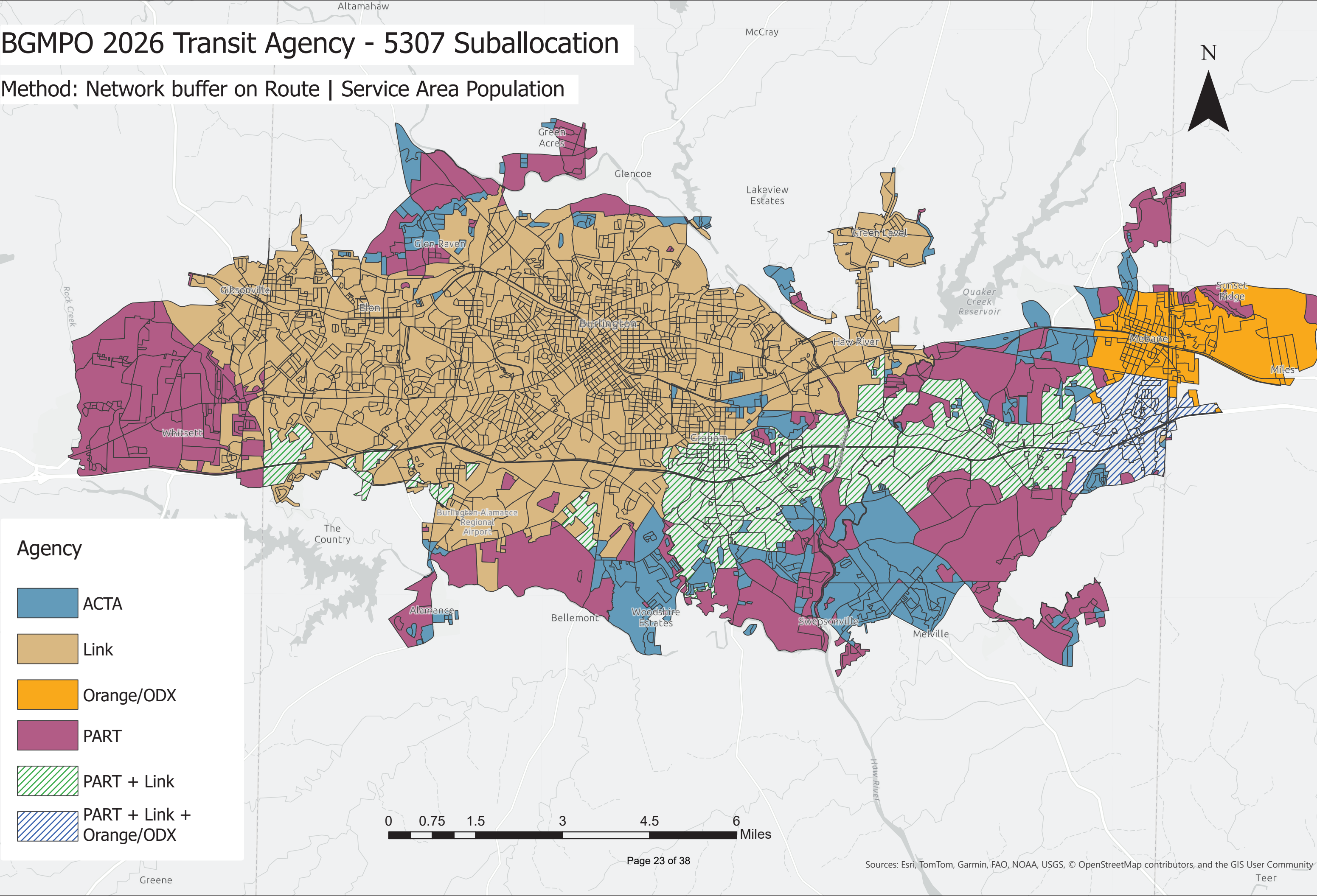

NCDOT released new online tool - "Projects Near Me"

NCDOT recently launched an interactive online tool called Projects Near Me, where people can explore a map featuring a wide range of state transportation project data. The map is searchable by address, making it easy to find projects near any location, and by project identification number (STIP ID). It can also display projects by county or NCDOT Highway Division.

Additional filters allow users to search the map by project mode: aviation, bicycle and pedestrian, bridge and structure, ferry, highway, public transit, rail, and other miscellaneous projects. The map can also display indicators for projects that are of high public interest, have public engagement, or are future projects. Users can click on any map pin to display more project information, including a local map and description of the work, milestones for those that are committed for funding in the current STIP, and contact information.
