<u>INFORMATION:</u> The Alamance County Transportation Authority (ACTA) contracted KFH Group, Inc. to develop its Community Connectivity Plan (CCP). The CCP is a five-year plan that outlines ACTA's initiatives for FY 2019 – 2023. The plan identifies the need to study the coordination of service among the regional and local transit agencies. Section 2 of the report outlines strategic actions and recommends a study be conducted including the transit providers and NCDOT Public Transit Division to identify opportunities for a higher degree of coordination and avoid duplication of services. #### 6) Triangle Region Air Quality Conformity

<u>INFORMATION</u>: The Triangle Region is required to demonstrate air quality conformity for the Triangle's Metropolitan Transportation Plans and TIPs. As a portion of the BGMPO planning area includes Orange County, the TAC is requested to approve the MTP/TIP conformity determination resolution and authorize the Chair to sign the resolution between 11/14/18 and 11/21/18 as the October TAC meeting will occur before the public/agency review comment period ends. The BGMPO is one of four organizations that will need to make determinations: 1) Durham-Chapel Hill-Carrboro MPO; 2) NC Capital Area MPO; 3) Burlington-Graham MPO (for the portion of Orange County in BGMPO jurisdiction); and, 4) NCDOT (for areas of the air quality region outside of MPO boundaries).

#### 7) SPOT 5.0 Division Needs List

INFORMATION: The intersection of NC 54 (Harden Street) and Riverbend Road was initially funded by High Impact/Low Cost monies. However, the proposed improvements will not resolve the need to align Riverbend Road with Johnson Avenue, install turn lanes on NC 54 and provide pedestrian amenities. NCDOT recommends the High Impact/Low Cost project be eliminated as the more comprehensive project scope would score well as a Division needs project. NCDOT has identified the intersection of NC 100 (University Drive) and Shallowford Church Road as a possible replacement and estimates the cost to install a right turn lane on Shallowford at \$250,000.

<u>INFORMATION</u>: At its May 15, 2018 meeting, the TAC assigned local input points to the BGMPO list of prioritized Regional Impact projects. The window for allocating local input points for Division Needs projects is September 3 to October 31, 2018. NCDOT requires letters of local match support for non-highway (bike/ped/rail/transit) projects that are programmed in the Draft 2020-2029 STIP. The BGMPO is in receipt of commitment letters from jurisdictions whose projects are under consideration. All jurisdictions can provide additional contributions to projects to help lower the cost to NCDOT by the point allocation deadline.
